  - (e) Photo Identity & address proof by PAN card & Aadhar card/Passport/Driving Licence/Voter's card/ Bank passbook with photograph/Photo Identity issued by a Gazetted Officer/Recognised college/university.
  - (f) Certificate of Post Qualification work experience (if any).
  - (g) Candidates belonging to SC/ST/OBC etc. must bring the respective Caste Certificate issued by the Competent Authority on the format prescribed by Govt. of India showing the Caste as notified by GOI from time to time. Please note that the Caste mentioned in the Certificate produced by you should conform to the Caste appearing in the Central Government List/Notification. Caste Certificate even with the slightest discrepancy in the name, spelling of the Caste, etc. shall not be acceptable. Candidate belonging to OBC Category should bring the latest OBC certificate in original along with attested copies thereof issued by the Competent Authority on the prescribed proforma issued specifically mentioning the Creamy Layer clause.
